

**2023 FFLA BOARD MEETING** 

**Zoom Meeting** 

January 14, 2023

The 2023 FFLA Board Meeting was held on January 14 with a video Zoom format. The meeting was called to order by Chairman Eells at 11:07 a. m. Eastern Time.

### MINUTES

The first order of business was approval of the 2022 board meeting minutes as distributed by Secretary Ray Grimes. Chris Haartz made the motion, seconded by Ray Grimes, to accept the minutes; with no corrections, the minutes were approved as distributed.

# ELECTION

Election Chair Rob Hoeye announced the results for 2023. There were four positions up for election; all nominees were elected: Western Deputy Chair - Michael Guerin, Southern Deputy Chair - Ron Stafford, Historian/Archivist - Kyle Stetler and Secretary - Ray Grimes. There were no write-ins the slate was elected as presented.

# **CHAIRMAN'S REPORT**

Brad Eells gave his report; in his report he touched on dry summer - wet winter conditions, new chapter dues, new directors, new local chapters, new affiliations, website, continue growth and activity, social media growth, New York's Light Up the Night, our current mission statement and

his desire to revamp it and include a vision statement, what we do, what about the FFLA, active local chapters, advocacy for human fire detection – both professional and volunteers, becoming well recognized in our world, what is our future, what is each one's role, fund raising, fostering community relationships, media opportunities, the need to promote - promote promote, and thanked everyone for all they do.

Keith Argow was asked to make any comments on the State of the FFLA address. He advised anything he was going to bring up, Brad had covered in his report. He also thanked everyone on the meeting for what they do.

# MEMBERSHIP, TREASURER, MAGAZINE REPORT

Gary summarized the Treasurer's report that had been sent to all board members and went over the income and expense categories. Membership was down 109 members from 1479 to 1370, but he reminded everyone that last year he had said the count was high due to the timing of the "drop" cycle, and that if you look at a two- or three-year summary, we have steady growth. Gary advised that he is still working to catch up with the Lookout Network magazine.
