PROJECTS AND ACTIVITIES:

1. Mount Washburn LO (Yellowstone NP) #576 - Work is almost complete on the addition of an external communications equipment apparatus. With most of the communications an electronics equipment moved to the new structure, the rehabilitation was supposed to proceed in 2020 but will now likely be done in 2021. FFLA worked with park staff this fall to develop the new interpretive panels inside the lookout observation deck. Project Status: ONGOING



Leviathan Peak LO (Humboldt-Toiyabe NF) #282 – FFLA officially commented on the NEPA planning document and thereafter was contact by the Forest Service to collaborate. Made initial contact with H-T staff to develop a plan for new use for this lookout, such as move to the Great Basin Learning Center. Project Status: LOOKING FOR STRUCTURAL ENGINEERING ASSESSMENT TO SEE IF LOOKOUT CAN BE MOVED.



- 3. Wisconsin Lookouts Coordination is ongoing, but sporadic, with Wisconsin SHPO to determine if there is some mechanism to slow down or prevent the sale of all the state managed lookouts. As many are located on leased private land parcels, the state has actively divested themselves of several lookouts. In 2019, the Wisconsin Chapter Director obtained data and information on several of the remaining lookouts and submitted it to the SHPO. They made a tentative decision that several of the lookouts were historic but that any further action would need to be taken by the state DNR. That agency however continues to show no interest in carrying that effort forward and sold simply dismantled, without attempting to auction several lookouts in 2020. Project Status: ONGOING
- 4. Coordination During SHPO coordination emails any information on projects I receive, is forwarded onto the appropriate chapter director so that they are aware of the project and everyone is informed. The full extent of that coordination is below in the table.

Washington	I did search through old emails just to check, because my memory is embarrassingly faulty. It looks like we did get a couple, one was an HPMP at High Rock Fire, and the other was a restoration plan at Burley Mountain. Attached is what we got from King County, it's Mount Peak. As it was a local project, I don't really have any more information. We didn't have any concerns, so we let it through without asking for more information.	
Oregon	I reviewed the cases we've had this year for lookouts, and a couple popped up. One was not really a 106 case, but a notice that Olallie Mountain Lookout had burned in one of the many wildfires we suffered this year. Here's the resource record for that one: https://heritagedata.prd.state.or.us/historic/index.cfm? do=v.dsp_siteSummary&resultDisplay=63179 Another was replacement of solar panels on Mt. Scott Lookout at Crater Lake NP (SHPO Case# 20-0900). The ones there now are pretty intrusive, they are replacing them with more efficient ones, mounted flush to the roof, which will greatly decrease the visibility, and reducing the load on the roof, which had needed supports before (now to be removed). We felt this to be no adverse effect, and a marked improvement over the current situation. I've attached the salient pieces of the submission.	
California	I haven't seen any in the past year.	
Arizona	No, I am not aware of any this year.	
New Mexico	It looks like we had one consultation that actually came in at the end of the year last year, so I don't know if I reported on it already. It was for maintenance on the Mangas Mountain Fire Lookout in the Gila National Forest, Catron County. We responded in early January 2020 with a conditional No Adverse Effect.	
Nevada	Thank you for reaching out to our office regarding Section 106 actions for Forest Fire Lookouts within the state of Nevada. For the calendar 2020 year, our office has not received any Section 106 undertakings regarding this property type.	
Wyoming	As far as I know, we didn't consult on any fire lookouts this year. I know that Yellowstone has made progress on Mount Washburn. I'm cc'ing Tobin so he can update you on the work they have done so far. Hope you are well. I'm retiring the end of the month, so Brian Beadles will be the Deputy SHPO and Sara Needles is SHPO after the first of January. Brian will be handling most of the day to day operations of the office.	

	On the Lele National Ferent: The first is a re-evaluation	
	On the Lolo National Forest: The first is a re-evaluation	
	of the eligibility status of the Cinnamon Bear Lookout.	
	The forest determined it Eligible for the National	
	Register under Criteria A and C and we concurred.	
	This is a platform lookout likely from the 1920s. The	
	second is the Henry West Fire Lookout. This lookout	
	was intentionally destroyed years ago (I think 1970s,	
	but I don't recall the exact date). Very little remains at	
	the location of the former lookout. The forest	
	determined it ineligible and we concurred. The forest	
	was also considering some work at the Priscilla	
	Lookout and reached out to our office for advice, but to	
	the best of our knowledge this project was cancelled or	
	postponed. Fish Wildlife Service was doing some	
Montana	rehab work at the CCC Lookout tower at Medicine	
	Lake. They did some improvements to the steps to	
	make the lookout more usable present day, but did not	
	impact any of the architectural features of the lookout.	
	The Helena-Lewis and Clark National Forest might	
	have a 106 project near Porphry Peak Lookout, an	
	energy company wants to build a large equipment	
	tower and we will be working with them to avoid	
	adverse effects (likely visual effects) to the lookout.	
	Perhaps the work at Priscilla will be restarted? My	
	hope is that agencies will put some of the Great	
	American Outdoors Act funding to restoring some	
	lookouts, but I have not been told of a potential project.	
	I'm not aware of any state lookout projects.	
	To my knowledge, we've only consulted on one fire	
	lookout this past year. Rocky Mountain National Park	
	has teamed with the Rocky Mountain Conservancy	
	and Anderson-Hallas Architects to complete a historic	
Colorado	structure assessment for its Shadow Mountain	
Colorado	Lookout (5GA300). The lookout was listed on the	
	National Register on August 2, 1978 and this planning	
	will inform future brick and mortar restoration. Dan

	Thank you for reaching out. We have not had any	
	projects pertaining to fire lookouts in South Dakota	
	come through for 106 consultation in the last year, and

We have not reviewed one of these since 2018.
Georgia	2020 has been a year, so I can understand why its only been once! I'm not remembering which ones we have talked about before, but one of the ones we saw earlier this year is the rehab of the Oaky Woods WMA fire tower. It is all talk at this point, so nothing has been done, but it might come to fruition. If so, it would most likely run through the Office of the State Archaeologist, and not our office (just a heads up!).	
Pennsylvania	It was the "Big Flat Fire Tower Demolition" in the Michaux State Forest (ER 2020-0236-041). There was mitigation - drone photograph documentation.	
North Carolina	We have had no federal actions involving Fire Lookout Towers this year. And, I haven't heard from the NCFS about any towers. I think they have slowed down a bit as their network of towers has pretty much been reduced to a minimum. Checking my records, I find that they have removed or sold 25 towers – 21 in 2017, 1 in 2019, 2 in 2016 and 1 in 2015. Some of the sales were for scrap. A few others were for private use, mostly hunting related. The problem is that our state preservation law only covers properties listed in the National Register and even then we can only recommend to the state agency that they find an alternative to demolition. Then, having gotten our recommendations, they do what they were planning to anyway. Sad, but true.	
South Carolina	We only had one request this year, it was for the Rosemary Fire Tower that is managed by Shaw AFB, see attached for their project review form and our response letter. We passed along the FFLA contact PDF and URL to Chip Ridgeway as a potential consulting party and he had emailed us backed that he tried to look up the Forest Fire Lookout Association's web page, but it appeared to be down. We also encouraged them to register the Rosemary Fire Tower on your list of towers. So it might be helpful to reach our directly to Mr. Ridgeway just so he has your contact information. His email information is in our response letter.	
New York	Based on a check of our online submission system it does not appear that any fire observation towers came to us for Section 106 reviews (or Section 14.09 of our state historic preservation act). We did, however, have one request from NYS DEC to evaluate the Graham Mountain Fire Observation Tower, Town of Hardenburgh, Ulster County. Based on the information provided by DEC we determined that this tower is NR eligible. DEC did not submit any associated work being done at this tower for our review; they simply asked for an evaluation of eligibility.	
Massachusetts	Since we last corresponded, no reviews were conducted by the Massachusetts Historical Commission (MHC) for fire lookout towers. I continue to remind staff to copy you at the FFLA on any reviews involving fire lookout towers.	

Vermont	We didn't have any consultations for fire lookouts this year. There has been on and off talks about two lookouts, Spruce and Elmore, but the projects haven't officially been submitted or reviewed yet.	
Alabama	I can't remember any such projects but I will run a query of our database and ask folks in other departments so I can be sure. I'll let you know what I find out.	
Maine	Our Section 106 consultation database contains the following projects relating to fire towers that were reviewed in 2020: Fire tower Cab replacement Allagash Mtn; Fire tower platform replacement Round Pond Mtn; Fire Tower Cab replacement Debouille Mtn	
Virginia	Thanks for reaching out. I can not find any record of DHR reviewing a project involving fire towers this year.	
Florida	I just checked our database and don't see any fire lookout projects.
